Crosby Straightpoint Bribery & Corruption Policy Statement

Crosby Straightpoint, part of Kito Crosby, recognises its obligations under the Bribery Act 2010, and is committed to implementing and enforcing effective systems to counter bribery and corruption. It is our policy to conduct all aspects of our business in an honest and ethical manner at all times. This policy applies to any person working for, or on behalf of the company, and for any person, company or organisation providing us with goods or services.

To demonstrate this commitment, we will not:

- Offer, promise, give, accept or demand contributions, of any kind, for the purpose of obtaining or retaining business, or any other commercial advantage;
- Provide excessive gifts or hospitality with the intention of inducing anyone to act improperly;
- Offer, or give in to demands, to make illicit or illegal payments to agents, public officials, or the employees of business partners of anyone else with whom we conduct business;
- Make illegal or inappropriate contributions to candidates for public office, or to political parties or other political organisations;
- Accept or offer 'kick-backs' or any other reciprocal agreements;
- Participate in cartels, cover pricing, bid rigging, or any other form of collusion.
- We will:
- Keep appropriate internal records that will evidence the business reason for making any payments to third parties;
- Raise awareness of the need to combat bribery and corruption with our business partners by publication of this Policy and (where appropriate) relevant contractual provisions and support initiatives designed to reduce the risk of bribery and corruption;
- Promote employee awareness of, and compliance with, company policies against bribery, and encourage any concerns about any
 issue or suspicion of malpractice to be raised at the earliest possible stage;
- Ensure that anyone raising a concern about bribery and/or corruption will not suffer any detriment as a result, even if they are found to be mistaken.
