Crosby Straightpoint RoHS Compliance - General Statement

Crosby Straightpoint, part of Kito Crosby, is committed to ensuring that any of our products placed on the market in Great Britain and/or Northern Ireland, and, within the European Union, are compliant the *Restriction of the use of Certain Substances in Electrical and Electronic Equipment Regulations 2012, S.I. 2012 No.3032, (as amended)*, and the *EU RoHS 2011/65/EU Regulations (as amended)*. Straightpoint (UK) Limited are aware and understand that these regulations aim to prevent hazardous substances from entering manufacturing processes, and hence out of production waste streams.

In accordance with Schedule A1, Restricted substances referred to in regulation 3 and maximum concentration values tolerated by weight in homogeneous materials, Crosby Straightpoint products are classified as 'monitoring and control instruments, including industrial monitoring and control instruments', and therefore, the restriction of substances containing Polybrominated Biphenyls/ethers, and phthalates, does not apply as set out in the Regulations.

The remaining applicable restricted substances, in relation to the in the manufacture of specified types of electrical and electronic equipment, are:

Substance	Restricted Limit (% by weight)	Restricted Limit (ppm)
Lead (Pb)	0.1	1,000
Mercury (Hg)	0.1	1,000
Hexavalent Chromium (Cr(VI))	0.1	1,000
Cadmium (Cd)	0.01	100

Crosby Straightpoint works diligently through internal design controls and supply chain declarations to ensure that all of our products and their packaging materials are compliant, according to the restrictions listed above.

Whilst this restriction does not legally apply to components, it is recognised that the component 'compliance' is relevant, and our suppliers of the components used in the manufacture of our products, have informed us that those components are 'RoHS Compliant'. Crosby Straightpoint have taken all reasonable steps to confirm these statements.

All of our products are CE and UKCA marked to confirm compliance with The RoHS and other applicable regulations and Standards. Product Technical Files are maintained to evidence compliance.
